**SUBJECT: FRANCHISE ORDINANCE AGREEMENT FOR RESIDENTIAL AND SMALL BUSINESS SOLID WASTE COLLECTION, TRANSPORTATION AND DISPOSAL SERVICES WITH OPTIONAL RECYCLING SERVICES IN FRANCHISE AREAS 9 AND 10 (ENVIRONMENTAL ASSISTANCE AND PROTECTION)**

**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:** Recommend Approval

**SUMMARY OF INFORMATION:** The current Franchise Holder providing solid waste collection services for franchised Areas 9 and 10 in the unincorporated area of the County, North Davidson Garbage Service, Inc., was recently purchased by Waste Industries USA, LLC dba GFL Environmental. Waste Industries has submitted an application for consideration to be awarded a new solid waste franchise to enable them to provide uninterrupted service for approximately 3,600 households currently subscribing for services in the affected areas. Waste Industries has demonstrated their qualifications for a solid waste management permit and has adequate equipment and staffing and sufficient financial resources and business experience to serve Franchise Areas 9 and 10.

**FRANCHISE ORDINANCE AGREEMENT FOR RESIDENTIAL AND SMALL  
BUSINESS SOLID WASTE COLLECTION, TRANSPORTATION AND DISPOSAL  
SERVICES WITH OPTIONAL RECYCLING SERVICES IN FRANCHISE  
AREAS 9 AND 10  
(ENVIRONMENTAL ASSISTANCE AND PROTECTION)**

**WHEREAS** pursuant to the authority provided by N.C. General Statutes, Chapter 153A, Chapter 19 of the Forsyth County Code, and other applicable laws, the Forsyth County Board of Commissioners hereby considers the following ordinance granting a franchise for residential and small business service collection, transportation, and disposal of solid waste to be in the best interests of Forsyth County;

**WHEREAS** North Davidson Garbage Service, Inc., is the current holder of the exclusive franchise for the collection, transportation, and proper disposal of solid waste for Areas 9 and 10 as authorized by Chapter 19 of the Forsyth County Code;

**WHEREAS** North Davidson Garbage Service, Inc., has sold all of its right, title, and interests in its business to Waste Industries USA, LLC doing business as GFL Environmental (“Waste Industries”);

**WHEREAS** for good cause shown, Waste Industries has requested that the Forsyth County Board of Commissioners discontinue North Davidson Garbage Service, Inc.’s exclusive franchise and grant an exclusive franchise for the collection, transportation, and proper disposal of solid waste for Franchise Areas 9 and 10 as authorized by Chapter 19 of the Forsyth County Code to Waste Industries;

**WHEREAS** pursuant to the provisions of Chapter 19 of the Forsyth County Code, Waste Industries has filed an application with the County Manager’s Office to operate a franchise for collection, transportation, and disposal of solid waste and/or recyclables in Areas 9 and 10;

**WHEREAS** Waste Industries has demonstrated qualifications for a solid waste management permit issued by Forsyth County, has equipment available to serve the proposed franchised areas, has sufficient financial resources and the business experience to serve franchised Areas 9 and 10; and Waste Industries agrees to be bound by and fully comply with all provisions of the Forsyth County Code, and other applicable laws, and the exclusive franchise to collect, transport, and dispose of solid waste in Areas 9 and 10 of Forsyth County; therefore, the County Manager recommends that an exclusive franchise be granted to Waste Industries to serve Areas 9 and 10 of Forsyth County;

**WHEREAS** for good cause shown, a grant of an exclusive franchise for Areas 9 and 10 to Waste Industries would be in the best interests of the citizens of Forsyth County; and

**WHEREAS** the Forsyth County Board of Commissioners is satisfied that the proposed franchise holder has demonstrated the qualifications for a solid waste management permit issued by the County to collect and transport solid waste and will comply with all applicable regulations, and will render prompt, efficient, and continuing service to the areas for which their franchise is granted, and that the proposed franchise holder has sufficient equipment and personnel to render the proposed services to all within their respective franchise areas;

**NOW, THEREFORE, BE IT ORDAINED**, that the Forsyth County Board of Commissioners hereby grants a franchise for residential and small business service collection,

transportation and disposal of solid waste to Waste Industries pursuant to the following terms and conditions:

**Section 1. Franchise Holder**

A franchise for the residential and small business service collection, transportation and disposal of solid waste is hereby granted, as listed herein below, to the following persons, firm and/or corporation to provide services to the areas indicated. This franchise is granted based on the condition that the firm listed herein provide optional curbside recycling collection service to all eligible properties within their franchised service areas. For purposes of this ordinance, "private corporation" means a corporation in which the shares of stock are closely held or not publicly traded. This Ordinance shall amend the Ordinance which was adopted and became effective January 1, 2019, which granted franchises for residential and small business service collection, transportation, and disposal of solid waste in unincorporated areas of Forsyth County, such that the franchise granted to North Davidson Garbage Service, Inc., is hereby terminated and the franchise for Areas 9 and 10 is hereby granted as follows:

This Ordinance shall have no effect upon the franchises for areas of Forsyth County other than Areas 9 and 10.

**Section 2. Franchise Area**

With the exclusion of land areas located within incorporated municipalities, the residential and small business franchise holder as set forth in Section 1 above is hereby granted a franchise for the areas designated in Section 1 of this ordinance, as further described in the attached documents entitled "Map of Franchise Areas" and "Descriptions of Residential and Small Business Service Franchise Areas", which documents are incorporated herein by reference, and are on file and available for public inspection in the office of the Clerk to the Board of Commissioners. The documents designate the franchise areas by franchise numbers.

**Section 3. Nature of Franchises**

The franchise granted herein for residential and small business service collection, transportation and disposal of solid waste shall be and is hereby adopted as an exclusive franchise within the areas designated.

**Section 4. Period of Franchise**

The franchise for residential and small business service collection, transportation and disposal of solid waste is hereby granted for a period beginning September 26, 2019, through December 31, 2021. This franchise will be automatically extended for two additional two-year terms unless the County or the franchise holder provides one hundred eighty (180) days' written

notice of termination prior to the expiration of the initial term or of either of the two, two-year additional terms.

**Section 5. Establishment of Limits on Fees for Certain Residential and Small Business Solid Waste Collection, Transportation and Disposal Services**

- (a) (i) There are hereby established and imposed limits on fees for collection, transportation, and disposal for residential and small business solid waste service in the amount of \$14.57 per household/location per month for curbside pickup (which includes the State Solid Waste Disposal Tax), not including a fuel surcharge fee which is adjusted quarterly based on the average price of diesel fuel during the preceding ninety-day period and determined using Exhibit A which is attached hereto and incorporated herein by reference per household per month as authorized by the Forsyth County Board of Commissioners on May 12, 2008. This fee shall be charged for once per week collection of no more than 64 gallons of solid waste. Subscribers with additional volume shall be charged additional fees at a rate of \$5.00 per month for each additional 32 gallons of solid waste collected weekly.
- (ii) The fee for collection, transportation, and disposal for residential and small business solid waste service currently in the amount of \$14.57 per household per month may be reviewed and adjusted by the Forsyth County Board of Commissioners in its sole discretion in a proportional amount based on average amount of household waste in response to any increases in the tipping rate charged to franchise collectors by the landfill or disposal facility.
- (b) Subscribers with special needs and approved documentation shall receive back yard collection services for no additional fees if the containers are not more than one hundred fifty (150) feet from a passable public road and access is free from interference from dangerous animals or other obstructions. Any subscriber requesting back yard collection must submit proof of special needs to the County Manager or his designated representative. In its sole discretion, the County shall determine whether such special needs exist.
- (c) Residential and small business franchise holders may charge an additional three dollars (\$3.00) per month for rent of roll-out containers that may be provided by the franchise holder upon request by the subscriber.
- (d) Franchise holders are authorized by this ordinance to bill subscribers for no more than three (3) months in advance of services rendered.

**Section 6. Fees for Additional or Special Services**

The fees for optional curbside recycling collection, transportation, and disposal services will not be regulated by Forsyth County.

Holders of franchises for residential and small business service are hereby granted a non-exclusive franchise for additional or special services which may include the collection, transportation and disposal of yard waste, demolition materials, white goods, and tires, but does not apply to the collection, transportation or disposal of containerized commercial and industrial material, which is not covered by this Ordinance. The franchise holders must comply with all applicable laws, regulations and other permits, which may be required in providing these services. Fees charged for such additional or special services may be agreed upon by the

franchise holder and subscriber, subject to review and approval by the County Manager as to reasonableness if it is deemed advisable.

Notwithstanding anything to the contrary herein, the County reserves the right to award an exclusive franchise for the collection, transportation and disposal of yard waste, demolition materials, white goods, tires, and recyclable materials, or any one or more of these materials. At such time as an exclusive franchise is awarded for the collection, transportation, and disposal of any such material, all non-exclusive franchises for the collection, transportation, and disposal of the same material shall immediately terminate.

**Section 7. Authority to Adjust Franchise Fees**

- (a) Except as authorized by Subsections 7(b) and 9(h), the fees for residential and small business solid waste collection, transportation, and disposal services as outlined in Subsection 5 above may only be revised by action of the Forsyth County Board of Commissioners and shall not be adjusted during the first two years of the initial term of the franchise.
- (b) The fuel surcharge will continue in effect and shall apply to the fees for weekly services set out in Section 5(a).

**Section 8. Required Service**

- (a) Within each franchise area, the assigned franchise holder must provide service once per week to everyone who requests it for residential and small business solid waste collection, transportation, and disposal and related additional or special services as authorized herein. The Board of Commissioners may from time to time require residential and small business solid waste franchise holders to provide special programs of solid waste collection, transportation and disposal sponsored and paid for by the County.
- (b) Each Franchise Holder must provide optional curbside recycling collection, transportation, and disposal service within their assigned franchise areas. Service will consist of curbside single stream collection of recyclables from a container provided by the Subscriber or by the Franchise Holder. Multiple containers may be used; however, the basis for service shall be collection of up to ninety-six (96) gallons of total volume of recyclables at least once every two weeks. The service provider will be responsible for providing each recycling Subscriber with a sticker or label to clearly identify each container designated for recyclables. Each Franchise Holder must provide service to any household or small business in their designated franchise areas that requests recycling service, unless the party is more than thirty (30) days in arrears in payment for such service.

**Section 9. Additional Conditions and Requirements**

- (a) Residential and small business solid waste containers shall be watertight metal or plastic containers with covers. Back yard service shall be provided by the franchise holder for any authorized subscriber with special needs, if the containers are not more than one hundred fifty (150) feet from a passable public road and access is free from interference from dangerous animals or other obstructions.
- (b) After first obtaining approval from the County Manager's Office, during emergencies, to ensure uninterrupted service within each residential and small business solid waste franchise area, adjoining franchise holders shall provide collection, transportation, and disposal services and assistance for a period not to

exceed ninety (90) days to franchise areas without service. It shall be the responsibility of the franchise holder of the area without service to obtain the necessary approval from the County Manager's Office and to arrange for the service and assistance, and to resolve financial compensation for said service and assistance.

- (c) The Board of Commissioners or the County Manager may require franchise holders to submit such information and reports as the Board or the Manager deem necessary or advisable in the administration of this ordinance. The minimum quarterly reporting requirements for each three-month billing period shall include but may not be limited to the total quantity of solid waste collected by the franchise holder, in tons; the total quantity of recyclables collected by the franchise holder, in tons; the total number of subscribers for solid waste collection service; the total number of subscribers for recycling collection service; the number of new subscribers; and the number of subscribers whose service was terminated for any reason. Quarterly reports are due by the 15th day of the first month following the end of each quarter (April 15, June 15, October 15, January 15).

The following items and information shall be provided to the County upon request: a sample quarterly bill or invoice for subscribers receiving basic collection service for up to 64 gallons of weekly volume of solid waste; a sample quarterly bill or invoice for subscribers receiving weekly collection service for up to 96 gallons of solid waste; the names and addresses of subscribers for solid waste and/or recycling collection services.

- (d) "Once per week" means the same day each week service except for extreme weather conditions (snow or ice), equipment breakdowns, or holidays. Service shall be resumed as quickly as possible following any unavoidable delay.
- (e) "Once every two weeks" means the same day every other week service except for extreme weather conditions (snow or ice), equipment breakdowns, or holidays. Service shall be resumed as quickly as possible following any unavoidable delay.
- (f) All solid waste collected under this Ordinance must be deposited at a municipal solid waste landfill or transfer station with a valid state permit.
- (g) All recyclables collected by franchise holders must be deposited at a Materials Recovery Facility approved by the County Manager or his designated representative.
- (h) In the event of new technological developments or collection methods that the Board of County Commissioners deems beneficial to the citizens of Forsyth County, the County reserves the right to amend and renegotiate these franchises to implement such methods. This could include adjustments in authorized fees or financial compensation to franchise holders.
- (i) Franchise holders must have a local customer service telephone number and contact person in North Carolina and shall make every reasonable effort to respond to telephone and e-mail inquiries by subscribers, potential subscribers, and County administration, within 24 hours, during the regular business week or on the next business day following contact on a weekend or holiday.

**Section 10. Record of Franchise**

Approved franchise applications and the documents described in this ordinance and in Section 19-51 of the Forsyth County Code shall be maintained and kept on file in the office of the Clerk to the Board of Commissioners.

Franchise holders shall provide subscribers with a written schedule for collection of solid waste and/or recyclables.

**Section 11. Termination of Franchise**

Franchise holders must provide the County Manager at least one hundred eighty (180) days' prior written notice of intent to terminate their franchise or discontinue any services in the franchise area. Franchise holders may not sell or otherwise transfer the franchise to any other provider in exchange for any consideration. If a franchise holder fails to provide services as required in this ordinance, the County Manager shall have the authority to suspend the franchise subject to possible termination by the Board of County Commissioners as provided in Section 19-50 of the Forsyth County Code.

**Section 12. Applicable Laws and Regulations**

The franchises granted by this ordinance and their continuation are conditioned upon the franchise holder's compliance with all applicable federal, state and local laws and regulations, particularly those relating to residential and small business solid waste collection, transportation, and disposal, including but not limited to Chapter 19 of the Forsyth County Code. The franchises and their continuation are also conditioned upon Forsyth County's continued jurisdiction, legal authority, and decision to administer and control the area of residential and small business solid waste collection, transportation and disposal.

**Section 13. Effective Date**

This ordinance becomes effective on September 26, 2019.

# Map of Franchise Areas

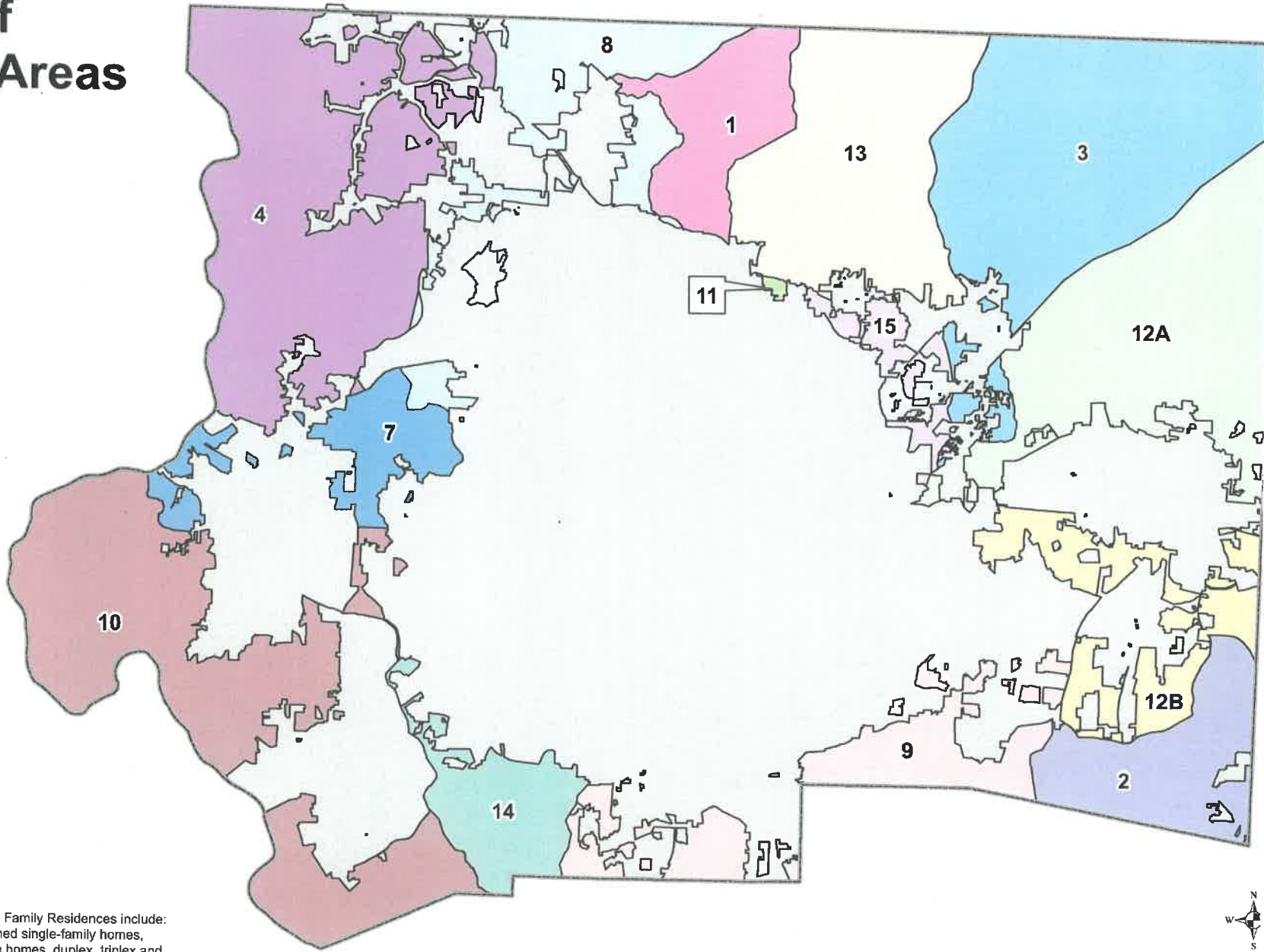

## **Descriptions of Residential and Small Business Service Franchise Areas**

Area 1

Description of Residential and Small Business Service Franchise Areas

North Boundary: Highway 65 from county line west to the intersection of Highway 65 and College Road.

West Boundary: College Road south to intersection of College Road and Lucy Branch, the boundary follows path of Lucy Branch to Rough Fork Creek; then Rough Fork Creek south to the intersection of Stanleyville Drive and Phelps Circle.

South Boundary: Phelps Circle from Stanleyville Drive east to Highway 66; Highway 66 east to the intersection of Route 66 and Old Rural Hall Road.

East Boundary: From intersection of Highway 66 and Old Rural Hall Road north to the intersection of Merry Dale Drive and the Rural Hall/Oak Summit school district line; the boundary follows the Rural Hall/Oak Summit school district line north to Red Bank Road; the boundary follows Red Bank Road north to Tesh Road; at Tesh Road the boundary continues north/west to the end of Blueberry Hill Drive then follows the suburban fire district to the county line.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.

Area 2

North Boundary: County line west following Bunker Hill-Sandy Ridge Road to the intersection of Bunker Hill-Sandy Ridge Road and U.S. 66. The boundary follows U.S. 66 south from the intersection of Bunker Hill-Sandy Ridge Road to the intersection of U.S. 66 and Watkins Ford Road. Watkins Ford Road west to the intersection of Watkins Ford Road and U.S. 311. U.S. 311 west to the intersection of U.S. 311 and Mary Relch Creek.

West Boundary: Mary Relch Creek from its intersection with U.S. 311 to the Forsyth/Davidson county line.

South Boundary: The Forsyth/Davidson county line from its intersection with Mary Relch Creek to where it meets the Forsyth/Gulford county line.

East Boundary: Forsyth/Gulford county line from its intersection with the Forsyth/Davidson county line to its intersection with Bunker Hill-Sandy Ridge Road.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.

Area 3

North Boundary: Forsyth/Stokes county line from its intersection with the Forsyth/Gulford county line to its intersection with U.S. 311.

West Boundary: U.S. 311 from the Forsyth/Stokes county line to the intersection of U.S. 311 and state road 1982. The boundary proceeds from the intersection of state road 1982 and U.S. 311 to the intersection of U.S. 66 and Old Walkertown Road; then follows U.S. 66 to its intersection with Mill Creek.

South Boundary: Mill Creek from its intersections with U.S. 66 to its intersection with Martin Mill Creek. Martin Mill Creek from its intersection with Mill Creek to its intersection with the Walkertown/Piney Grove fire district line.

East Boundary: The boundary proceeds from the intersection of the northeast/Piney Grove fire district line and Martin Mill Creek to the intersection of U.S. 66 and U.S. 158. U.S. 158 to the Forsyth/Gulford county line. Forsyth/Gulford county line to its intersection with the Forsyth/Stokes county line.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.

area 4

North Boundary: Forsyth/Stokes county line from its intersection with Jefferson Church Road to its intersection with the Forsyth/Surry county line.

West Boundary: Forsyth/Surry county line from its intersection with the Forsyth/Stokes county line to its intersection with the Forsyth/Yadkin county line. The Forsyth/Yadkin county line from its intersection with the Forsyth/Surry county line to its intersection with Yadkinville Highway (Old 421).

South Boundary: Yadkinville Highway from its intersection with the Forsyth/Yadkin county line to approximately one fourth mile east of the intersection Yadkinville Highway and Old Road.

East Boundary: The boundary extends from a point on Yadkinville Highway approximately one fourth mile east of its intersection with Old Road to the intersection of Clinedale Road and Skylark Road; from the intersection of Clinedale Road and Skylark Road to the intersection of Highway 65 and Highway 67; the boundary follows the line of the Old Richmond/Oldtown school districts north to their intersection with Mizpah Church Road; the boundary proceeds east on Mizpah Church Road to its intersection with the Oldtown Township line, then north following the Oldtown Township line to its intersection with Tobaccoville Road; the franchise boundary extends east along Tobaccoville Road to its intersection with Jefferson Church Road; the boundary then proceeds along Jefferson Church Road from its intersection with Tobaccoville Road to the Forsyth/Stokes county line.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.

North Boundary: Yadkinville Highway from a point approximately one fourth mile east of its intersection with Old Road to the Forsyth/Yadkin county line.

West Boundary: The Forsyth/Yadkin county line from its intersection with Yadkinville Highway to a point adjacent to the end of Dorse Road; then proceeding across county to Dorse Road.

South Boundary: Dorse Road from its end to its intersection with Shallowford Road. Shallowford Road from its intersection with Dorse Road to its intersection with the southern boundary of Vienna Township. The southern boundary of Vienna Township to its intersection with the eastern boundary of Vienna Township.

East Boundary: The eastern boundary of Vienna Township from its origin to its intersection with Muddy Creek. Muddy Creek around Buckingham Park Development to the end of Wessex Road. From the end of Wessex Road to boundary proceeds to a point on Yadkinville Highway approximately one fourth mile east of the intersection with Old Road.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.

Area 8

North Boundary: Forsyth/Stokes county line from its intersection with Rt. #8 to its intersection with Jefferson Church Road.

West Boundary: Jefferson Church Road from the Forsyth/Stokes county line to its intersection with Tobaccoville Road. Tobaccoville Road west to its intersection with Old Richmond Township line; the Old Richmond Township line south to its intersection Mizpah Church Road; Mizpah Church Road west to its intersection with the Old Richmond/Oldtown school districts line; the Old Richmond/Oldtown school district line south to its intersection with Highway 65 and Highway 67; from the Highway 65 and Highway 67 the boundary proceeds to the intersection Clinedale Road and Skylark Road; from the intersection of Clinedale and Skylark road the boundary extends to a point on the Yadkinville Highway approximately 1/4 mile east of its intersection with Old Road; the boundary extends to this point to the end of Wessex Road; from the end of Wessex Road the boundary follows Muddy Creek around Buckingham Park development to its intersection with the eastern boundary of Vienna Township; the boundary of Vienna Township to the Winston-Salem city limit.

South Boundary: Winston-Salem city limits.

East Boundary: Rt. #8 from its intersection with the Winston-Salem city limits to its intersection with Whittier Road; from the intersection from #8 and Whitter Road to the eastern end of Marlborough Lane to the intersection of U.S. 66 and Rt. #8; Highway 66 from its intersection with Rt. #8 to its intersection with Phelps Circle; Phelps Circle with its intersection with Stanleyville Drive; Rough Fork Creek from its intersection with Stanleyville Drive north to Lucy Branch Creek; Lucy Branch Creek north to its intersection with College Road; College Road north to its intersection with Highway 65; Highway 65 from its intersection with College Road to the Forsyth/Stokes county line.

\*\*NOTE: Franchised areas are reduced by annexation by incorporated towns, cities or villages.



area 9

North Boundary: Winston-Salem city limits from its intersection with Linville Road to its intersection with Old Salisbury Road.

West Boundary: Old Salisbury Road from its intersection with the Winston-Salem city limits to its intersection with Clemmonsville Road; Clemmonsville Road from its intersection with Old Salisbury Road to its intersection with Ebert Road; Ebert Road from its intersection with Clemmonsville Road to Friedburg Church Road crossing it and intersecting the Forsyth/Davidson county line.

South Boundary: Forsyth/Davidson county line just south of intersection of Ebert Road and Friedburg Church Road to its intersection with Mary Reich Creek.

East Boundary: Mary Reich Creek from the Forsyth/Davidson county line to the intersection of Highway 311 and Union Cross Road; Union Cross Road from its intersection with 311 to its intersection with Glenn High Road; Glenn High Road from its intersection with Union Cross Road to its intersection with Oak Grove Road; Oak Grove Road from its intersection with Glenn High Road to its intersection with Highway 150; Highway 150 from its intersection with Oak Grove Road to its intersection with Linville Road; Linville Road from its intersection with Highway 150 to the Winston-Salem city limits.

**\*\*NOTE:** Franchised areas are reduced by annexation by incorporated towns, cities or villages.

Area 10
