FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes March 14, 2024 – 2:00 p.m.

Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Thursday, March 14, 2024, at **2:00** p.m., Chairperson Robert Durrah, Jr. presiding.

Pledge of Allegiance

Chairperson Robert Durrah, Jr. led the Pledge of Allegiance.

Moment of Silence

Chairperson Robert Durrah, Jr. led a moment of silence.

Public Comments

None

Approval of Absentee Ballots

Director Tsujii presented to the Board 8 total of approved absentee ballots and 53 for disapproval. Of the 8 approved ballots, 3 are pending cure and 1 is from the last meeting with a voter ID exception form. Secretary Doomy motioned to approve the 8 approved ballots and disapprove the 53; Member Draper seconded. **Motion carried unanimously.**

Director Tsujii informed the Board that a correction to the number of disapproved ballots needed to be made and that the total was 49 and not 53 ballots. Secretary Doomy amended his motion for 53 disapproved ballots to a motion of 49 disapproved ballots; Vice Chair Jourdan seconded. **Motion carried unanimously.**

Board Members signed Zero Reports for the DS850 high-speed scanner.

Board Members signed absentee voter reports for the approved and disapproved ballots.

Approval of Provisional Ballots

Kay Moore, Voter Registration Manager, presented to the Board the provisional ballots for review. A total of 526 ballots were presented with 169 for approval, 102 for partial approval, 232 for disapproval, and 23 as pending.

Member Draper motioned to approve 169 ballots and 102 partially approved ballots, and to disapprove 232 ballots; Secretary Doomy seconded. **Motion carried unanimously.**

Member Draper moved to keep the 23 pending ballots open for cure until 10:30 a.m. tomorrow, March 15, 2024; Secretary Doomy seconded. **Motion carried unanimously.**

Tabulation of Absentee Ballots and Provisional Ballots

Ballots that did not scan in the high-speed central counter due to tears and folds were marked spoiled. The board members duplicated the spoiled ballots, and the ballots were properly scanned through the high-speed central counter.

Director Tsujii informs the Board that an amended motion is needed on the number of provisional ballots approved. Vice Chair Jourdan calls for an amended motion. Secretary Doomy moved to amend the previous motion and moved to approve 170 provisional ballots and 101 partially approved provisional ballots; Member Draper seconded. **Motion carried unanimously.**

Other Business

Director Tsujii reviews draft of plan for the combined polling places for the second primary election on May 14, 2024 and a draft of the recommendation of early voting dates and times. The republican races for NC Lieutenant Governor and NC Auditor are the contests which will be on the second primary ballot. A back up contingency plan for polling places will also be presented tomorrow, March 15, 2024.
