

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 14 4-602.11 Equipment Food-Contact Surfaces and Utensils-Frequency - P Repeat. Various size of plastic containers (total of 5) were soiled with debris or residue. Food-contact surfaces of equipment and utensils shall be clean to sight and touch. CDI: Items taken to the 3 compartment sink.
- 39 3-304.14 Wiping Cloths, Use Limitation - C Repeat. One of the sanitizing bucket with no quat by the hot holding line closest to the wall. Containers of chemical sanitizing solutions specified in Subparagraph (B)(1) of this section in which wet wiping cloths are held between uses shall be stored off the floor and used in a manner that prevents contamination of FOOD, EQUIPMENT, UTENSILS, LINENS, SINGLE-SERVICE, or SINGLE-USE ARTICLES. CDI: Employee discarded the solution and filled up quat from the 3 compartment sink (quat 300).
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat. Exposed insulation due to missing screw or just the screw on the small hot holding units (metal bar missing). Ice build up hanging on the pipe inside the walk in freezer. Caulk hanging on the right inner side of the hood system. Equipment shall be maintained in good repair.//4-502.11 (A) and (C) Good Repair and Calibration-Utensils and Temperature and Pressure Measuring Devices - C Cracked with separation plastic holder insert, hole in gray plastic bin, and wire sticking out from the whisk. UTENSILS shall be maintained in a state of repair or shall be discarded.
 Lock CDI: Person in charge discarded the plastic holder and bin.//4-402.11 Fixed Equipment, Spacing or Sealing-Installation - C Caulk Text missing with food debris between the make unit and work table facing the storage shelving. EQUIPMENT that is fixed because it is not EASILY MOVABLE shall be SEALED to adjoining EQUIPMENT or walls, if the EQUIPMENT is exposed to spillage or seepage.

- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C Low grout between the floor tiles by the Frymaster area. Floors, floor coverings, walls, wall coverings, and ceilings shall be designed, constructed, and installed so they are SMOOTH and EASILY CLEANABLE.
