Member Loughridge moved to close public comments; Member Jourdan seconded; Motion carried unanimously.

Approval of Meeting Minutes

Secretary Durrah moved to approve meeting mintues for July 2, 2020 as presented; Member Jourdan seconded; **Motion carried unanimously**.

Consideration of One-Stop Early Voting Plan for the November 3, 2020, General Election

Chairperson Campbell brought back from the table the Consideration of One-Stop Early Voting Plan for the November 3, 2020, General Election, providing an overview of the sites being considered for Early Voting. Deputy Director Bobadilla provided insight to First Assembly Church, noting that the site would not be adequate to be a mega/super site nor would it accommodate consolidating other sites; however, would be adequate as an additional Early Voting site. Ms. Bobadilla also provided information on the Truist Stadium noting that like First Assembly would be a viable additional site but would not be adequate as a mega/supersite. Chairperson Campbell inquired about the Benson University Center at Wake Forest; Deputy Director stated that the site is difficult to access and lines would be a complication. Chairperson Campbell called for comments. The Board provided comments regarding Hanes Mall and the need for a mega/super site for the east side of Winston Salem. Member Jourdan inquired about Winston Lake YMCA and the possibility of using it as a mega/supersite and if the site had been secured. Ms. Bobadilla stated that is was in the process of being confirmed for use. The Board also discussed Early Voting days and hours. Member Durrah requested financial data to determine the impact for Early Voting, voting by Absentee ballot, and Election Day in which costs for three Saturdays and one Sunday are included. The Board and Staff discussed the outlook for poll workers and the potential for filling the positions. Member Loughridge moved to table the Consideration of One-Stop Early Voting Plan for November 3, 2020, General election for further information; Secretary Durrah seconded; Motion carried unanimously.

Other Business

Chairperson Campbell requested that Director Tsujii address questions received from the public regarding In-Person voting, Same Day Registration, protections for voters, and poll worker response plan. Mr. Tsujii emphasized personal protection equipment on all fronts to enable a seamless voter experience to all. Director Tsujii also addressed the Same Day Registration process, the identification and proof of residency requirements for those seeking to register to vote during Early Voting. Mr. Tsujii also addressed the processes for duplicate registration checks for in-state as well as the interstate cross-check process by the State Board of Elections.
