- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P Chlorine sanitizer in one spray bottle was at low concentration, not registering on test strips. Chlorine sanitizer shall be kept at a concentration between 50 and 100 ppm. CDI: sanitizer was remixed to 100 ppm CDI.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P One bowl of cut cabbage was stored out of cold holding equipment at 46F. All potentially hazardous foods including cut leafy greens shall be stored in cold holding equipment. CDI: Cabbage moved to walk in cooler. CDI.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Caulking is peeling out of the hood above the deep fryers. Wire shelving in the walk in cooler is starting to rust. Equipment shall be maintained in good repair. Repair noted items.
