- 1 2-102.12 Certified Food Protection Manager - C Employee working today did not have a current food safety certification (REHS looked up certificate on ServSafe website; it expired in 2018). At least one employee who has supervisory and management responsibility and the authority to direct and control food prep and service shall be a certified food protection manager who has shown proficiency of required information through passing a test that is part of an ANSI accredited program.
- 26 7-102.11 Common Name-Working Containers - PF 7-202.12 Conditions of Use - P,PF Bottle labeled "Sanitizer" contained a bluish liquid that tested over 400 ppm with quat test strips (test strip turned blue); per employee, it appears that window cleaner or another chemical was placed in this bottle (the concentrated sanitizer is clear). Working containers used for storing poisonous or toxic materials such as cleaners and sanitizers taken from bulk supplies shall be clearly and individually identified with the common name of the material. Poisonous or toxic materials shall be used according to Law and Food Code, and applied so that a hazard to employees or other persons is not constituted. CDI - contents of bottle emptied, bottle rinsed; employee properly mixed sanitizer to 200 ppm in spray bottle.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C Replace missing ceiling tile above bag-in-box rack in back kitchen area. Seal around pipes that enter the ceiling. Ceilings shall be designed, constructed, and installed so they are smooth and easily cleanable. REPEAT from previous 2 inspections.
