RESOLUTION AWARDING AND AUTHORIZING EXECUTION OF A CONTRACT FOR JANITORIAL SERVICES FOR THE FORSYTH COUNTY BEHAVIORAL HEALTH COMPLEX BUILDINGS (GENERAL SERVICES DEPARTMENT)

WHEREAS, after due advertisement, proposals were received at 12:00 noon, Wednesday, May 29, 2013 in response to Forsyth County's Request for Proposals, to provide janitorial services for the Forsyth County Behavioral Health Complex buildings located at 725 Highland Avenue and 651 Highland Avenue, Winston-Salem and the following proposals based on annual cost were received:

Taprock Enterprises, Inc., dba Jani-King of the Triad	\$51,420.00
Rifco Services, Ins., dba Jan-Pro Cleaning Systems of the Triad	\$54,468.96
The Budd Group, Inc.	\$66,876.00
All Floors Cleaning, LLC	\$68,550.00

WHEREAS, it is the recommendation of the County Manager, the Forsyth County General Services Director, and the Purchasing Director that a contract to provide janitorial services for the Forsyth County Behavioral Health Complex buildings located at 725 Highland Avenue and 651 Highland Avenue, Winston-Salem, for an initial one year term, July 1, 2013 through June 30, 2014, be awarded to Taprock Enterprises, Inc., dba Jani-King of the Triad at the annual cost of \$51,420.00, with the option to extend the contract in one-year increments for up to two additional 12 month periods, at the same annual cost, provided that both parties are in agreement and funds are available for this purpose; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract to provide janitorial services for the Forsyth County Behavioral Health Complex buildings, located at 725 Highland Avenue and 651 Highland Avenue, Winston-Salem, for an initial one year term of July 1, 2013 through June 30, 2014, is hereby awarded to Taprock Enterprises, Inc., dba Jani-King of the Triad in the annual amount of \$51,420 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED, that Forsyth County reserves the right to extend the contract at the same annual cost, in one-year increments for up to two additional 12 month periods, provided that both parties are in agreement and funds are available for this purpose.

BE IT FURTHER RESOLVED, that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Taprock Enterprises, Inc., dba Jani-King of the Triad consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
