**SUMMARY OF INFORMATION:**

The Forsyth County Public Library has been awarded a grant in the amount of \$96,930 from Kate B. Reynolds Charitable Trust, Poor & Needy Division, to enhance preschool spaces in the children's area of the new Central Library and improve resources to aid children ages 0-5 in their overall development and kindergarten readiness as an ongoing component of the Trust's "Great Expectations" early childhood development initiative. These grant funds can be utilized by the Library to support the following plan:

- Create an easily recognizable learning space within the new Central Library with child friendly art, furnishings, educational toys and technology that will attract early preschoolers and provide an area that is engaging and promotes a positive literacy experience.
- Update the current collection with age appropriate books, materials and story time kits that reflect social and behavioral issues for small children.
- Purchase additional materials for literacy training sessions that benefit parents and caregivers emphasizing the importance of literacy and the impact it has on a young child's future for learning.
- Purchase technology stations that showcase pre-literacy activities that are hands on and engaging.
