**RESOLUTION AUTHORIZING EXECUTION OF A SOFTWARE
SERVICE AGREEMENT BETWEEN FORSYTH COUNTY AND
ONIX NETWORKING CORP. TO PROVIDE
E-MAIL AND DATA COLLABORATION SOLUTIONS
(FORSYTH COUNTY MANAGEMENT INFORMATION
SERVICES DEPARTMENT)**

WHEREAS, on October 24, 2016, the Forsyth County Board of Commissioners authorized the execution of a 3-year Agreement with Cloud Sherpas, Inc., to provide e-mail and data collaboration services for the period October 29, 2016 through October 28, 2019; and

WHEREAS, Cloud Sherpas, Inc., has terminated its Agreement with the County effective October 27, 2018; and

WHEREAS, the County has received the following bids to provide e-mail and data collaboration services for a year, beginning October 27, 2018:

Onix Networking Corp.	\$147,276.00
Dito, LLC	\$162,000.00
Suitebriar, Inc.	\$162,000.00

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, a software service Agreement between Forsyth County, on behalf of its Management Information Services Department, and Onix Networking Corp. to provide e-mail and data collaboration solutions at an annual cost of \$147,276.00, for the period October 27, 2018 through October 27, 2019, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney, and to enter into subsequent contracts for these services and amendments thereto within budgeted appropriations in the current and future fiscal years.
