**SUBJECT: AMENDMENT TO THE FY2018-2019 BUDGET ORDINANCE TO APPROPRIATE ADDITIONAL FUNDS FROM THE NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF PUBLIC HEALTH, EPIDEMIOLOGY AND COMMUNICABLE DISEASE BRANCH TO ENHANCE LATENT TUBERCULOSIS INFECTION SCREENING AND TREATMENT (FORSYTH COUNTY DEPARTMENT OF PUBLIC HEALTH)**

**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:**

**SUMMARY OF INFORMATION:**

The Forsyth County Department of Public Health received notification of an additional allocation of \$3,326 from the North Carolina Department of Health and Human Services, Division of Public Health, Epidemiology and Communicable Disease Branch to enhance Latent Tuberculosis Infection Screening and Treatment.

Funds may be used to purchase supplies, etc. to enhance Tuberculosis screening efforts for high risk populations that are at increased risk for latent tuberculosis infection such as those who live in or have lived in 1) countries with high prevalence of tuberculosis or 2) high risk congregate settings such as homeless shelters or correctional facilities. Latent Tuberculosis Infection is when a person is infected with mycobacterium tuberculosis but does not have active tuberculosis. Active tuberculosis can be contagious while latent tuberculosis is not, and it is, therefore, not possible to get tuberculosis from someone with latent tuberculosis.

Funds associated with this amendment must be spent by December 31, 2018, as they are a part of a federal grant which requires the funds be spent by that date.

 Agreement Addendum Revision # 1

- I. Background:** No change.
- II. Purpose:**  
This Agreement Addendum Revision #1 provides additional funding to enhance latent tuberculosis (TB) infection (LTBI) screening and treatment, as described in Section III below. These additional funds restore the Local Health Department’s funding to its 2016 level for this Activity and are now available due to the recent approval by the CDC of the state’s carryover funding request.
- III. Scope of Work and Deliverables:**  
*As of November 1, 2018, this Agreement Addendum Revision #1 adds Paragraph 10 as follows:*  
10. Expand targeted testing for LTBI and support any resulting LTBI treatment needed, including purchasing supplies needed to do so. In addition to contacts of sputum AFB smear-positive TB patients, the Local Health Department will prioritize populations at increased risk for LTBI, such as people who live in or have lived in 1) countries with high prevalence of TB, or 2) high-risk congregate settings (such as homeless shelters or correctional facilities), in accordance with 2016 U.S. Preventive Services Task Force recommendations for LTBI screening among adults (USPSTF, *Screening for Latent Tuberculosis Infection in Adults*. JAMA 316(9): 962-969).
- IV. Performance Measures/Reporting Requirements:** No change.
- V. Performance Monitoring and Quality Assurance:** No change.
- VI. Funding Guidelines or Restrictions:**  
*As of November 1, 2018, this Agreement Addendum Revision #1 adds Paragraph 4 as follows:*  
4. The funds associated with this Agreement Addendum Revision #1 **must be spent by December 31, 2018** as they are part of a federal grant which requires these funds to be spent by that date.
