SUMMARY OF INFORMATION:

The results of the FY 2018 year-end audit created \$13,182,632 in available funds. The purpose of this agenda item is to appropriate available Unreserved Fund Balance for the creation of the 2018 Pay-Go Capital Projects Ordinance, amend the 2017 Court Facilities Capital Projects Ordinance to reduce the amount of Limited Obligation Bonds that will be issued, and create the 2018 First and Chestnut Parking Capital Projects Ordinance.

Pay-Go funds are used whenever possible for four primary reasons: debt avoidance, projects with a positive return on investment, capital projects, and economic development. For the 2018 Pay-Go Capital Projects Ordinance, each project, unless previously authorized to proceed, will be brought back before the Board for authorization prior to starting the project.

The Fiscal Year 2018-2019 Budget Ordinance identified three projects that could be funded if sufficient pay-go funds were available. Additional projects have been identified as well, including capital maintenance for the Smith Reynolds Airport, a new 800 MHz digital trunked radio system that is jointly owned by the County and the City, equipment for the Lewisville Volunteer Fire Department's countywide dive rescue team, and additional funding for elections equipment.

The 2018 Pay-Go Capital Projects Ordinance will fund the following projects - Capital Maintenance Projects at Smith Reynolds Airport (\$1,150,000), Elections Equipment (\$750,000), and New 800 MHz Radio System (\$4,282,632).

It is also recommended that \$7,000,000 be transferred to the 2018 First and Chestnut Parking Capital Projects Ordinance. In addition to the \$7,000,000 of Pay-Go funding, an additional \$8.5 million in 2/3rds Bonds will be issued to fully fund a six and a half floor, 660 space parking facility.

The 2017 Court Facilities CPO will be amended to reduce the total amount of Limited Obligation Bonds that will be issued as \$4,084,800 for parking was originally included in the total \$120,000,000 budget.

For the 2018 Pay-Go Capital Projects Ordinance, each project, unless previously authorized to proceed, will be brought back before the Board for authorization prior to starting the project.

The Fiscal Year 2018-2019 Budget Ordinance identified three projects that could be funded if sufficient pay-go funds were available. Additional projects have been identified as well, including capital maintenance for the Smith Reynolds Airport, a new 800 MHz digital trunked radio system that is jointly owned by the County and the City, equipment for the Lewisville Volunteer Fire Department's countywide dive rescue team, and additional funding for elections equipment.

With the available Pay-Go funding available, it is the recommendation of staff that \$7,000,000 be transferred to the 2018 First and Chestnut Parking Capital Projects Ordinance. In addition, the 2018 Pay-Go Capital Projects Ordinance should have the following amounts appropriated: \$1,150,000 for capital maintenance projects at Smith Reynolds Airport, \$750,000 for new elections equipment, and \$4,232,632 for the new 800 MHz radio system.
