WHEREAS, attached and incorporated herein is a two-page listing of personal property items that have been replaced by various Forsyth County departments and are surplus to the needs of the County; and

WHEREAS, N.C.G.S. 160A-270 authorizes Counties to sell surplus personal property by public electronic auction; and
