Depositing of any waste in unauthorized areas is a crime. Depending on the circumstances, charges can range from misdemeanor to felony and result in heavy fines.



Dumping illegally is on the rise in North Carolina. Illegal dumps are not just ugly; they also threaten the health of humans and pets, damage the environment, lower property values and can discourage economic development. Tax dollars needed for other programs are used to clean up dumping sites and dispose of waste properly.

Serious Health Risk for Humans and Environment

Air Quality Risks

Decaying dumps produce offensive odors as well as gases such as hydrogen sulfide and methane. These gases are explosive when present in high enough concentrations.

Contamination of Surface Water & Groundwater Risks

Chemicals and solvents dumped as well as chemicals produced by decaying dumps can affect water quality by washing into local streams or moving through soil layers to contaminate groundwater. This could threaten drinking water, pet health and wildlife health.

Chemical Hazards

Chemical hazards threaten water quality and also adults, children and pets who come across illegally dumped materials. Items such as batteries, asbestos (which is used in floor tiles, shingles and many other building products), and cleaning compounds, all present hazards.

Safety Hazards

Dumped materials present physical safety hazards. For example, children have become trapped and suffocated in abandoned appliances. Other safety hazards commonly found in dump sites include needles, broken glass and other sharp objects.

Mosquito Problems

Standing water accumulates in old tires, aluminum cans and other objects. This stagnant water provides perfect habitat for mosquitoes to breed. Some mosquitoes can transmit serious viruses like West Nile Virus to humans and heartworms to dogs.



Mosquitoes only need <u>one week</u> of stagnant water to complete their life cycle !

Dumping Costs Us All

- Location (as specific as possible)
- Time of day and date of dumping
- Type of material
- License plate number
- Color, make and model of vehicle
- Name of business on vehicle
