The County Commissioners appoint an HHS board that serves in an advisory capacity and have statutory responsibilities for Public Health and Social Services. The current HHS Board Chair is Heather Parker. The current HHS Director is Shontell Robinson, who also serves as a Deputy County Manager.

# **Learn More About HHS**

We want to ensure our residents are aware of the many services and resources that Health and Human Services offers. Below includes information on several programs, services, and resources:

## Men's Health Program

The Men's Health program is a male based community outreach program that helps men become knowledgeable of chronic diseases and prevention. The program focuses on chronic diseases and other health topics, such as nutrition, physical activity, mental health, and dad and son relationships. ## **Preventive Dental Health Program**

We are pleased to recognize 50 years of service from the Preventive Dental Health Program, the longest-running program in Public Health. The goal of the program is to help the community, particularly children, create healthy smiles that will last a lifetime by providing non-clinical, preventative dental health services including, but not limited to, oral health assessments and referrals for children within Forsyth County. The education provided by our dedicated team of specially trained public health hygienists has helped Forsyth County stay one step ahead of dental disease since 1974. While our community has grown and evolved over the years, our commitment to disease prevention and overall health promotion has not wavered. ## **Stepping Up Initiative**

The Forsyth County Stepping Up Initiative houses two programs: Stepping Up Process to End Recidivism (SUPER) and the Mental Health Court (MHC). The goal of both programs is to help participants to prevent recidivism (returning to jail).

- The SUPER program provides screening, recovery planning, peer support, and case management to persons who have mental health or substance use disorders. The program serves men and women who have criminal justice involvement and assists those who may not have any legal issues.
- The MHC program is a court supervised treatment program for people who have been identified as having a mental illness, pending charges, and have agreed to participate in the program. MHC is a pre-plea court that links eligible defendants to treatment and support services that help them better manage their mental health. Charges are dismissed upon graduation from the program.

#### **SUN Bucks**

North Carolina's newest food assistance program will begin in summer 2024. SUN Bucks will provide grocery-buying benefits to qualifying families with school-aged children during the summer months when schools are on summer break. SUN Bucks is sometimes referred to as Summer EBT.

SUN Bucks benefits are issued to debit-like cards (EBT cards) that families can use to purchase nutritious food. Beginning in summer 2024, families will receive \$120 per eligible child for the summer period. Please click here for more information: <u>SUN Bucks | NCDHHS</u>

## Women, Infants, and Children Program (WIC)

WIC is a federally funded health and nutrition program for women, infants, and children. WIC helps families by providing checks for buying healthy supplemental foods from WIC-authorized vendors, nutrition education, and help finding healthcare and other community services. # **Community Partnership Highlight**

Bridges to Hope Family Justice Center, Forsyth County Government, and Wake Forest School of Medicine hosted *Collaboration for Safety and Accountability of Nonfatal Strangulation*, March 8th, 8:30 am-2:00 pm at Forsyth County Central Library. The Honorable Jim O'Neill, Forsyth County District Attorney, offered opening remarks regarding his experiences as a prosecutor and how his knowledge of the topic has expanded through the years.

The event also included The Honorable Valene McMasters, JD, District Court Judge, Forsyth County, who provided a perspective from her role as part of the local judiciary. Judge McMasters offered insight on traumainformed courts, her role and responsibility in the court system, and factors she considers in criminal and civil cases related to interpersonal violence.

Participants represented a wide range of disciplines including law enforcement, healthcare providers, social workers, advocates, public health professionals, civil and criminal court systems, academia, and other human services providers. The training culminated in facilitated discussion from participants for creating recommended guidelines for Forsyth County for responding to survivors of interpersonal violence who experience nonfatal strangulation.
