March 27, 2026 – 1:00 p.m.

Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the 2nd Floor Board Room on Friday, March 27, 2026 at 1:00 p.m., Chairperson A.L. Collins presiding.

Motion to Approve Meeting Agenda

Chairperson Collins called for a motion to approve the meeting agenda. Member Draper moved to approve the agenda as presented; Member Harvey seconded. **Motion carried unanimously.**

Review of Provisional Ballots

Director Tim Tsujii informed the Board that four provisional voters who were previously disapproved are now to be approved, in accordance with Numbered Memo 2025-02, which states: “Accordingly, the provisional votes cast by Registration and Repair voters (i.e., ‘Inactive’ with the reason ‘DL/SSN-Update Record’) for federal contests must be counted, unless the voter is ineligible for some other reason.” Two of the ballots were counted on Election Day, and the remaining two will be scanned today. Vice Chair Jourdan moved to approve the provisional ballots as presented; Secretary Doomy seconded. **Motion carried unanimously.**
