- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P Raw chicken stored over beef in walk in cooler. Store raw foods in order of cook temperature, with the highest cook temperature located on the bottom. CDI. Items rearranged to reflect proper order of storage.
- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P Ice guard in ice maker had mold present. Buffalo chopper stored in clean dish area has food debris in it. Food contact surfaces shall be clean to sight and touch. CDI. Both items cleaned/sanitized during inspection.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P Shredded cheese and cream cheese on breakfast bar 61-63 degrees. Items were not placed into temperature control along the bar. Potentially hazardous food shall be cold held at 45 degrees or less. CDI. Items discarded.

- 37 3-307.11 Miscellaneous Sources of Contamination - C Apples available at breakfast bar not wrapped or under sneeze guard. Because apples have edible skin, they must be protected from contamination while on display. Bowl of honey and bowl of brown sugar at breakfast bar uncovered and not under sneeze guard. Cover food containers to prevent them from becoming contaminated.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C 0 points. Cleaning needed of stovetop and surrounding area. Non food contact surfaces of equipment shall be clean.
- 53 6-501.11 Repairing-Premises, Structures, Attachments, and Fixtures-Methods - C 0 points. Repair minor tile damage behind front hand sink and in front of right 2 door cooler.
- 54 6-403.11 Designated Areas-Employee Accommodations for eating / drinking/smoking - C 0 points. Employee drink observed in dressing cooler among restaurant food. Employee food and drink shall be stored in designated areas where they cannot contaminate food or clean utensils. Reccomend designating a bin on lowest shelf of cooler for employee items.CDI. Drink relocated during inspection.
