- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C Repeat: Floor tiles under three compartment sink are damaged and bowing out. Water from three compartment sink is splashing onto the tiles and causing water to pool around them and cause the damage. Recommend extending the drain to be further over the floor sink to prevent splash. / Repeat: cabinets at drink station had broken door hinges that need to be replaced so doors can be easily opened for cleaning and do not fall off. / Physical facilities shall be kept in good repair.
