

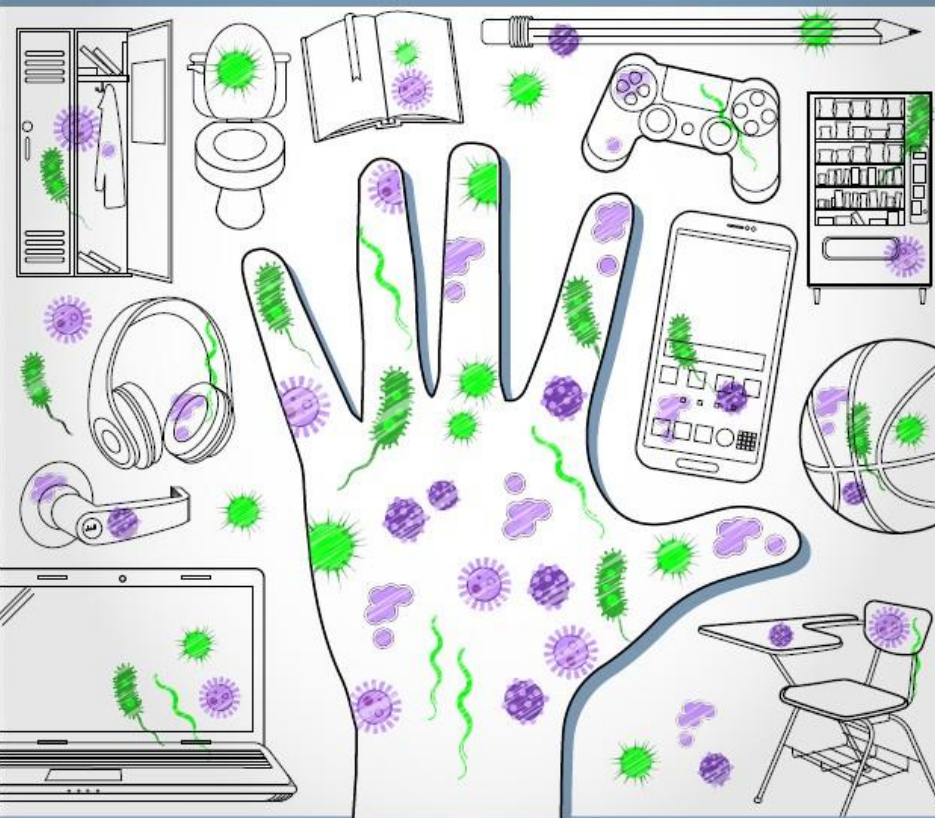

VISITATION SECURITY

- ❖ All visitors are required to clear a walk through metal detector. After three (3) unsuccessful attempts of clearing the walkthrough metal detector, the visitor shall be denied entrance and it shall be explained that he/she can come back during the next visitation period or another day. All visitors are subject to a frisk search as needed.
- ❖ VISITORS WITH MEDICAL DEVICES AND/OR MEDICAL IMPLANTS, SUCH AS PACEMAKERS ARE REQUIRED TO NOTIFY THE RECEPTIONIST AND SECURITY OFFICERS OF THEIR MEDICAL DEVICES BEFORE THEY ARE PROCESSED IN THE FACILITY FOR VISITATION.
- ❖ The **ONLY** items allowed for visitation are: **I.D.'s and Keys**. All “other items” must be secured in the PUBLIC LOBBY LOCKERS for \$0.50 or VEHICLE at your own risk.

IMPORTANT NOTICE:

Any person caught with any item not permitted during visitation risk being asked to leave the facility and/or VISITATION PRIVILEGES BEING REVOKED.

Todos los visitantes están sujetos a una búsqueda según sea necesario.

- ◊ Los ÚNICOS artículos permitidos para las visitas son: I.D. y llaves. Todos los "otros artículos" deben estar asegurados en los LOCKERS PUBLICOS DE VESTÍBULO por \$ 0.50 o VEHÍCULO bajo su propio riesgo.

Tobacco Free Facility

Any person who knowingly gives or sells any tobacco product, including vapors products, as defined in G.S. 148-23.1 to an inmate or to a person who is not an inmate, for delivery to an inmate in the custody of a local confinement facility, is guilty of a Class 1 misdemeanor.

Any inmate of a local confinement facility who possesses any tobacco product, as defined in G.S. 148-23.1, other than for authorized religious purposes, is guilty of a Class 1 misdemeanor.

Cell Phone Free Facility

Any person who knowingly gives or sells a mobile telephone or other wireless communications device, or a component of one of those devices, to an inmate or to a person who is not an inmate, for delivery to an inmate in the custody of a local confinement facility, is guilty of a Class H felony.

Any inmate of a local confinement facility who possesses a mobile telephone or other wireless communications device or a component of one of those devices, is guilty of a Class H felony.

Cualquier persona que a sabiendas da o vende cualquier producto de tabaco, incluidos los productos de vapores, tal como se define en GS 148-23.1 a un preso o a una persona que no es un preso, para su entrega a un preso bajo la custodia de un centro de confinamiento local, es culpable de un delito menor de clase 1.

Cualquier recluso de una instalación de confinamiento local que posea cualquier producto de tabaco, según se define en G.S. 148-23.1, que no sea para fines religiosos autorizados, es culpable de un delito menor de Clase 1.

Instalación gratuita de teléfono celular

Cualquier persona que a sabiendas le dé o venda un teléfono móvil u otro dispositivo de comunicaciones inalámbrico, o un componente de uno de esos dispositivos, a un preso o a una persona que no sea un preso, para entregarlo a un preso bajo la custodia de un confinamiento local instalación, es culpable de un delito grave de clase H.

Cualquier preso de una instalación de confinamiento local que posea un teléfono móvil u otro dispositivo de comunicaciones inalámbrico o un componente de uno de esos dispositivos, es culpable de un delito mayor de Clase H.

- ❖ Inmates are allowed Two (2) adult visits per week. (Sunday through Saturday)
- ❖ Visitors under the age of sixteen (16) do not require an I.D. and they “do not” count as a visitor. Only two (2) children per adult are permitted.
- ❖ Any visitor under the age of eighteen (18) years must be accompanied by a parent or legal guardian. Documentation of legal guardianship must be provided to detention staff. The accompanied minor by a parent or legal guardian counts as a visitor.
- ❖ Inmates who receive Friday Only visitation receive only one visit per week on a first come first serve basis.
- ❖ *NOTE: The parent or legal guardian must remain with the visitor under the age of 18 for the duration of the visit. Failure to properly supervise children may result in the visitation termination and/or removal from the public lobby.*

- ◊ Se permite a los reclusos dos (2) visitas de adultos por semana. (Domingo a sábado)
- ◊ Los visitantes menores de dieciséis (16) años no requieren un I.D. y ellos "no" cuentan como visitante. Solo se permiten dos (2) niños por adulto.
- ◊ Cualquier visitante menor de dieciocho (18) años de edad debe estar acompañado por un padre o tutor legal. La documentación de la tutela legal debe proporcionarse al personal de detención. El menor acompañado por un padre o tutor legal cuenta como visitante.
- ◊ Los reclusos que reciben la visita solo el viernes solo reciben una visita por semana por orden de llegada.
- ◊ NOTA: El padre o tutor legal debe permanecer con el visitante menor de 18 años durante la visita. El no supervisar adecuadamente a los niños puede resultar en la terminación de la visita y / o el retiro del lobby público.

VISITATION DRESS CODE

Forsyth County Law Enforcement Detention Center visitors are required to dress in appropriate attire when visiting inmates.

- ❖ *No sundresses or shirts that are backless*
- ❖ *No one-shoulder or off-shoulder blouses or tops*
- ❖ *No tank top – male or female*
- ❖ *No hats or head coverings*
- ❖ *No clothing that will reveal female breast or excessive cleavage*
- ❖ *No clothing that exposes midriffs or bellybuttons*
- ❖ *No mini skirts or shorts that do not reach mid-thigh*
- ❖ *No boots/shoes with metal*
- ❖ *No house/bedroom shoes*
- ❖ *No clothing with offensive logos, pictures, and/or writing*
- ❖ *No pants worn below the waistline that exposes the buttock area*
- ❖ *NOTE: Individuals that are inappropriately dressed for visitation will be “DENIED”*

- ◊ Sin sombreros ni coberturas en la cabeza.
- ◊ No puede usar ropa que revele el pecho femenino o el escote excesivo.
- ◊ No hay ropa que exponga la cintura o los ombligos.
- ◊ No hay minifaldas o shorts que no alcancen la mitad del muslo.
- ◊ No botas / zapatos con metal.
- ◊ No zapatos de casa / dormitorio
- ◊ Sin ropa con logos, imágenes y / o escritos ofensivos.
- ◊ No se usan pantalones debajo de la cintura que exponen el área de las nalgas
- ◊ NOTA: Las personas que estén vestidas inadecuadamente para las visitas serán "DENEGADAS"

- ❖ Note: Visitors are not permitted to sign up for visitation 30 minutes before visitation ends.
- ❖ Note: Visitation days are subject to change at any time and without prior notice.
- ❖ Note: Inmate's visitation days are dictated by where the inmate is housed and inmates housing assignments may change at anytime. Therefore the inmate's visitation days may change. The reception staff will notify visitors if the inmate's visitation days have changed and what visitation days the inmate will be allowed to have visitors.

NEW INMATE MAIL PROCESS

INMATE MAIL POLICY

Effective 07/15/2024 all non-legal inmate mail with the exception of publications must be sent to the following address:

The envelope must include the Facility Name, Inmate Name, Inmate ID number, and the Facility ID or the mail will NOT be scanned. The Facility ID for Forsyth County Law Enforcement Detention Center NC is 5067.

The envelope must have a complete, legible return address including the sender's first and last name or the mail will NOT be scanned.

The sender is responsible for postage. Mail with insufficient postage will be refused.

Mail sent to the facility will be returned to sender after 08/01/2024.

MAIL REQUIREMENTS AND RESTRICTIONS:

- NO cash, personal checks, or money orders mailed to the mail processing center
- Mail must be 10 pages or less per envelope
- Page size must be no larger than 8.5" x 11"
- Mail can include written or typed pages, photos, drawings or greeting cards (NO Polaroid photos)
- NO glitter, glue, tape, 3D elements, or electronic components (lights, music, animation)
- NO items containing, depicting, or relating to sexually explicit activity, gang activity, illegal activity, violence, drug, or alcohol use, etc.
- NO photos of nude or partially clothed persons
- NO illegal substances or any other items considered to be contraband
- NO magazines, books, or packages mailed to mail processing center, NO publications of any kind.
- NO originals of important documents or photos such as Birth Certificates, Driver's Licenses, Social Security Cards, Green Cards, etc., as they will not be returned

Mail meeting these requirements will be scanned and can be accessed by the inmate via the inmate tablet. Physical mail will be destroyed.

All scanned mail containing materials considered illegal or breaches of security will be turned over to the proper authorities for investigation. Any threats of criminal activity will not be permitted in any correspondence and may result in criminal charges.

NEW INMATE MAIL PROCESS

LEGAL MAIL / PRIVILEGED MAIL & PUBLICATIONS

Do not mail legal/privileged mail to the mail processing center.

Legal mail and publications are the only mail accepted at the facility. Legal mail must be mailed directly to the facility. Legal mail must be marked on the envelope as "Legal Mail" and will be opened in the presence of the inmate. Publications must be sent directly from an approved publisher/distributor.

SCANNED MAIL AFTER RELEASE:

After release, an inmate can request digital copies of his or her scanned mail. Submit the request to inmatemail@fcso.us. The request must include:

Once the information is verified, an email with a link to download the postal scans will be sent to the email address provided in the request.
